GENERAL ACADEMIC INFORMATION

Minimum Minor Requirements

- 9 credit hours
- 2.5 Minor GPA; all courses must have a grade of "C-" or better.
- Residency: All 9 credit hours of the minor must be completed while registered at UCCS.

NOTE: Speak with an academic advisor in Main Hall, 2nd floor, to declare a minor.

All 9 credit hours of business courses for the minor must be taken in residence in the College of Business and must not already be counting toward an area of emphasis. If the 9 hours are not unique courses, then a student cannot earn a minor. Courses taken for the minor can fulfill business course requirements.
